A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT & CONSTRUCTION FOR THE SUPPLY & DELIVERY OF PLASTIC DRUM/BARRELS FOR THE TEMPORARY STORAGE FOR MEDICAL WASTE, PATHOLOGICAL AND INFECTIOUS AS MANDATED BY REPUBLIC ACT 9003
