A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE & CONSTRUCTION SUPPLY FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE MATERIALS AND SUPPLIES FOR THE CHRISTMAS IN WONDERLAND 2023 AT TABACO CITY PLAZA, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 23-10-1520** with an Approved Budget for the Contract (ABC) of **Php 599,890.00**;
