### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JS ZAMORA CONSTRUCTION FOR THE JO-LABOR, EQUIPMENT RENTAL AND MATERIALS FOR THE INSTALLATION OF FIRE HYDRANTS AT VARIOUS LOCATIONS, TABACO CITY
