A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO B & C ELECTROMECH FOR THE JO-LABOR & MATERIALS FOR THE FABRICATION OF STAINLESS DUMP BOX, DISMANTLE AND INSTALLATION OF NEW SUB-CHASSIS
