A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GEN. MDSE. FOR THE SUPPLY & DELIVERY OF VARIOUS DRUGS MEDICINES AND MEDICAL SUPPLIES FOR COMPREHENSIVE MATERNAL AND CHILD HEALTH PROGRAM

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request 23-06-0758 with an Approved Budget for the Contract (ABC) of Php 299,994.90
