A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KRMKA GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF VARIOUS CHEMICALS FOR SANITARY LANDFILL WASTEWATER TREATMENT FACILITY AND PUBLIC MARKET SEWAGE TREATMENT FACILITY, TABACO CITY
