A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LUCKY EDUCATIONAL SUPPLY INC. FOR THE SUPPLY & DELIVERY OF GENERAL SUPPLIES FOR EXECUTIVE DEPARTMENTS

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-09-1259** with an Approved Budget for the Contract (ABC) of **Php 495,868.00**

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

- a.) To award the contract to **Lucky Educational Supply Inc.** as the Supplier with the and Responsive Bid (LCRB) for this procurement.
- b.) To recommend to the City Mayor of Tabaco the award of contract to **Lucky Educational Supply Inc.** in the amount of **Three Hundred Fifty Six Thousand Six Hundred Forty One Pesos and Eighty Centavos (Php 356,641.80).**
