A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SAN CARLOS HARDWARE OPC FOR THE SUPPLY & DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLIES FOR THE REHABILITATION OF SAN ANTONIO LYING IN CLINIC AT SAN ANTONIO, TABACO CITY
