**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ARIM ALBAY ENTERPRISES FOR THE JO-SUPPLY & INSTALLATION OF ADDITIONAL 5.5KW P SOLAR PANEL AND 9.6KWHR BATTERY FOR EXISTING 8KW SOLAR HYBRID SOLAR SYSTEM AT MOTHER AND CHILD K-LINK AT BRGY. SAN ANTONIO, TABACO CITY**
