### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ASTRIDAIMOND CATERING SERVICES FOR THE MEALS FOR THE MENTAL HEALTH AWARENESS (CANDLE PARADE)
