**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KRMIKA GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF VARIOUS MATERIALS AND SUPPLIES FOR SUPPLEMENTATION OF COMPLEMENTARY FOOD TO 6-23 MONTHS OLD CHILDREN FEEDING SUPPLEMENTATION**
