A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO B & C ELECTROMECH FOR THE JO-LABOR & MATERIALS FOR THE INSTALLATION OF NEW SETS OF INJECTIONS AND INTAKE MANIFOLD HOSE FOR VEHICLE PLATE NO. FOC-167
