A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO YSSA'S BOTANICAL GARDEN FOR THE SUPPLY & DELIVERY OF VARIOUS SEEDS FOR BUFFER ZONE AT THE CENTRAL MATERIALS RECOVERY FACILITY
