### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO YSSA'S BOTANICAL GARDEN FOR THE JO-LABOR & MATERIALS FOR THE PROJECT LANDSCAPING OF KARANGAHAN PARK AT BRGY. BANGKILINGAN, TABACO CITY
