### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 168 GASOLINE ENTERPRISES FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE OIL AND LUBRICANTS FOR MOTORPOOL DIVISION

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-10-1440** with an Approved Budget for the Contract (ABC) of **Php 481,576.60**
