A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO EBB CONSUMER GOODS TRADING FOR THE SUPPLY & DELIVERY OF HYGIENE KIT FOR THE SANITATION AND HYGIENE LOWERS MALNUTRITION

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-10-1481** with an Approved Budget for the Contract (ABC) of **Php 125,800.00**

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:



WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


