A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO EXPONENT OFFICE & SCHOOL SUPPLIES FOR THE SUPPLY & DELIVERY OF VARIOUS MATERIALS AND SUPPLIES FOR THE NUTRITION PROGRAM ASSESSMENT CONFERENCE AND ENHANCEMENT ACTIVITY
