**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO RRS MARKETING FOR THE SUPPLY & DELIVERY OF AIR CONDITIONING SYSTEM**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request 23-10-1576 with an Approved Budget for the Contract (ABC) of Php 94,000.00

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

WHEREAS, upon careful examination of the price quotation of the supplier with the lowest quoted price, Rey-Son Repair Shop was found to be non-compliant with the requirements of the project. The line of business of Rey-Son is not similar to the project, hence its bid was disqualified.

WHEREAS, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, RRS Marketing, and it was found to be responsive with the requirements of the project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To award the contract to **RRS Marketing** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b.) To recommend to the City Mayor of Tabaco the award of contract to amount of **RRS Marketing** in the amount of **Ninety Three Thousand Four Hundred Pesos (Php 93,400.00)**.
