A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LION COMMERCIAL CORPORATION (LCC SUPERMARKET) FOR THE SUPPLY & DELIVERY OF GROCERY PACK FOR THE ADVOCACY PROGRAM FOR WOMEN
