A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR FOR THE SUPPLY & DELIVERY OF VARIOUS IT SUPPLIES FOR VARIOUS OFFICES-EXECUTIVE DEPARTMENT (BATCH 1)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-11-1624** with an Approved Budget for the Contract (ABC) of **Php 266,227.00**
