A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO GORILLA TRADING FOR THE JO-LABOR & MATERIALS FOR THE PRINTING OF PROMOTIONAL CATALOG AND BROCHURE
