### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KRIKA GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF ZEOLITE FOR SANITARY LANDFILL
