A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CASA VER AMORE INC. FOR THE MEALS & VENUE FOR THE TRAININGS AND RE-ORIENTATION SEMINAR ON STRENGTHENING CAPACITY/CAPABILITY DEVELOPMENT, BADAC/ADAC FUNCTIONALITY AND BCDP 2024

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 24-02-0033** with an Approved Budget for the Contract (ABC) of **Php 113,000.00**


