A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO LEGAZPI PREMIUM DEVELOPMENT CORP. FOR THE INSTALLATION/REHABILITATION/IMPROVEMENT OF VARIOUS INFRASTRUCTURE PROJECTS (STREETLIGHTING PROJECT, ROADWAYS & OTHER INFRASTRUCTURE) AT VARIOUS BARANGAYS, TABACO CITY UNDER CONTRACT ID NO. 004-02-2024-INFRA-PB

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Installation/Rehabilitation/Improvement of Various Infrastructure Projects (Streetlighting Project, Roadways & Other Infrastructure) at Various Barangays, Tabaco City under Contract ID No. 004-02-2024-INFRA-PB*, with an Approved Budget for the Contract (ABC) amounting to *Forty-Nine Million Three Hundred Eighty Thousand Pesos (Php 49,380,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) contractor had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on March 05, 2024, the BAC received one (1) bid;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid which resulted to the following, to wit:







- a) To declare the bid of *Legazpi Premium Development Corp.* as the Single Calculated Responsive Bid (SCRB) for the *Installation/Rehabilitation/Improvement of Various Infrastructure Projects (Streetlighting Project, Roadways & Other Infrastructure) at Various Barangays, Tabaco City under Contract ID No. 004-02-2024-INFRA-PB*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *Legazpi Premium Development Corp.* in the amount of *Forty-Eight Million One Hundred Forty-Five Thousand Seventy-Six Pesos and Fifty-Three Centavos (Php 48,145,076.53)*.
