BAC Resolution No. 2024-2Q-04-0192

**A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO 3RB CONSTRUCTION & SUPPLY FOR THE REHABILITATION OF VARIOUS INFRASTRUCTURE PROJECTS (FLOOD CONTROL, WATER SYSTEM & IRRIGATION CANAL), VARIOUS BARANGAYS, TABACO CITY UNDER CONTRACT ID NO. 005-02-2024-INFRA-PB**

**WHEREAS**, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Rehabilitation of Various Infrastructure Projects (Flood Control, Water System & Irrigation Canal), Various Barangays, Tabaco City under Contract ID No. 005-02-2024-INFRA-PB*, with an Approved Budget for the Contract (ABC) amounting to *Forty-Six Million Seven Hundred Forty-Six Thousand Seven Hundred Nineteen Pesos and Seventy-Eight Centavos (Php 46,746,719.78)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, eight (8) contractors had shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission of bids on March 12, 2024, the BAC received eight (8) bids;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

2. Norsam Builders & Construction Supply
3. Rolco Construction & Development Corp.

**WHEREAS**, the BAC immediately conducted the detailed evaluation of bids which resulted to the following, to wit:



**WHEREAS**, per post-qualification conducted by the BAC Technical Working Group (TWG) involving the verification and validation of legal, technical and financial documents of the bidder with single calculated bid, **3RB Construction & Supply** was found to be substantially compliant with the requirements of the said procurement and its bid has been found to be responsive;

**NOW THEREFORE**, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To declare the bid of **3RB Construction & Supply** as the Lowest Calculated Responsive Bid (LCRB) for the **Rehabilitation of Various Infrastructure Projects (Flood Control, Water System & Irrigation Canal), Various Barangays, Tabaco City under Contract ID No. 005-02-2024-INFRA-PB**; and
- b) To recommend to the City Mayor of Tabaco the award of contract to **3RB Construction & Supply** in the amount of **Forty-Five Million Three Hundred Forty-Four Thousand Eighty-Six Pesos and Seventy-Three Centavos (Php 45,344,086.73)**.


