BAC Resolution No. 2024-2Q-04- 0193

**A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO JAG-VAIL CONSTRUCTION & SUPPLY FOR THE REHABILITATION OF VARIOUS ROADWAYS, VARIOUS BARANGAYS, TABACO CITY UNDER CONTRACT ID NO. 006-02-2024-INFRA-PB**

**WHEREAS**, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Rehabilitation of Various Roadways, Various Barangays, Tabaco City under Contract ID No. 006-02-2024-INFRA-PB*, with an Approved Budget for the Contract (ABC) amounting to *Forty-Nine Million Five Hundred Thousand Pesos (Php 49,500,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, twelve (12) contractors had shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission of bids on March 12, 2024, the BAC received twelve (12) bids;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:



**WHEREAS**, per post-qualification conducted by the BAC Technical Working Group (TWG) involving the verification and validation of legal, technical and financial documents of the bidder with lowest calculated bid, *Jag-Vail Construction & Supply*, was found to be substantially compliant with the requirements of the said procurement and its bid has been found to be responsive;

**NOW THEREFORE**, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *Jag-Vail Construction & Supply* as the Lowest Calculated Responsive Bid (LCRB) for the *Rehabilitation of Various Roadways, Various Barangays, Tabaco City under Contract ID No. 006-02-2024-INFRA-PB*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *Jag-Vail Construction & Supply* in the amount of *Forty-Eight Million Four Hundred Fifteen Thousand Eighty-Three Pesos and Fifteen Centavos (Php 48,415,083.15)*.
