**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MR 88 ELECTRONICS TRADING FOR THE SUPPLY & DELIVERY OF SPLIT TYPE AIRCON FOR MARKET OFFICE**
