A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO POWER PRIME CAR SERVICE CENTER FOR THE SUPPLY & DELIVERY OF VARIOUS TIRES FOR VARIOUS SERVICE VEHICLES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-03-0234** with an Approved Budget for the Contract (ABC) of **Php 429,280.00**;
