**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT & CONSTRUCTION FOR THE JO-SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR THE INSTALLATION OF ANTI-LITTERING FENCE, CENTRAL MRF, BRGY. SAN VICENTE, TABACO CITY**

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


