BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO HESED PUBLISHING, INC. FOR THE SUPPLY & DELIVERY OF SUPPLEMENTARY INSTRUCTIONAL MATERIALS FOR GRADES 1, 2 AND 3, SDO-TABACO CITY






