A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE PARTS AND ACCESSORIES FOR VEHICLE SJH-118

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-03-0255** with an Approved Budget for the Contract (ABC) of **Php 225,027.10**;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


