A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO COTTON CITY MARKETING CORP. FOR THE SUPPLY & DELIVERY OF JACKETS, JOGGING PANTS AND CAPS FOR UNIFORM OF THE TABACO CITY DELEGATION FOR THE PALARONG BICOL 2024

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-04-0340** with an Approved Budget for the Contract (ABC) of **Php 340,100.00**;
