**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JS ZAMORA CONSTRUCTION FOR THE JO-LABOR, MATERIALS, EQUIPMENT FOR THE FABRICATION OF FURNITURE AND FIXTURE AT MALICTAY HEALTH CENTER AT HACIENDA, TABACO CITY**
