A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JYQ ENTERPRISES FOR THE JO-LABOR & MATERIALS FOR THE GENERAL BODY REPAIR AND MAINTENANCE OF DUMP TRUCK WITH CONDUCTION STICKER DOB 664 (TCE-06) OF CITY ENVIRONMENT & NATURAL RESOURCES OFFICE (CENRO)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-04-0403** with an Approved Budget for the Contract (ABC) of **Php 399,300.00**;


WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;
