A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KRMIKA GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF VARIOUS CHEMICALS FOR WASTEWATER TREATMENT FACILITY, SANITARY LANDFILL WASTEWATER TREATMENT FACILITY AND CENTRAL MATERIAL RECOVERY FACILITY
