A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 3GX COMPUTER & I.T. SOLUTIONS TECHNOSHOP FOR THE SUPPLY & DELIVERY OF DESKTOP COMPUTER
