A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JAMESTOWN BUILDERS & CONSTRUCTION SUPPLIES FOR THE JO-LABOR & MATERIALS FOR THE REPAIR / REHAB OF CITY HALL BUILDING AT CITY HALL ANNEX, TABACO CITY
