A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT & CONSTRUCTION FOR THE JO-SUPPLY OF LABOR, MATERIALS, AND EQUIPMENT FOR THE REHABILITATION/IMPROVEMENT OF TEMPORARY STORAGE FACILITY AT CENTRAL MRF, BRGY. SAN VICENTE, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-04-0439** with an Approved Budget for the Contract (ABC) of **Php 599,251.00**;
