**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT & CONSTRUCTION FOR THE SUPPLY, DELIVERY AND EQUIPMENT RENTAL FOR THE IMPROVEMENT OF MRF BUILDING AT VISITA, SAN MIGUEL ISLAND, TABACO CITY**
