A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JS ZAMORA CONSTRUCTION FOR THE JO-LABOR, MATERIALS AND EQUIPMENT RENTAL FOR THE REPAIR AND MAINTENANCE OF PINAGBOBONG WATER SYSTEM, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-05-0521** with an Approved Budget for the Contract (ABC) of **Php 579,303.00;**
