A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BAMBHIE MERCHANDISE FOR THE SUPPLY & DELIVERY OF VARIOUS INGREDIENTS FOR BREAD AND PASTRY PRODUCTION (BPP) NCII FOR 1ST QUARTER, BATCH 1-A AND BATCH 1-B

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-04-0279** with an Approved Budget for the Contract (ABC) of **Php 99,785.10**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;
