### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ROVIPHIL CONTRACTOR FOR THE JO-LABOR AND MATERIALS FOR THE MAINTENANCE OF TEMPORARY FACILITIES (FISH STALLS AND VEGETABLES SECTION)
