A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT & CONSTRUCTION FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE SUPPLIES FOR THE OPERATION AND MAINTENANCE AT CENTRAL MRF, SLF FACILITY, NURSERY AND GARBAGE TRUCK
