#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR FOR THE SUPPLY & DELIVERY OF VARIOUS IT EQUIPMENT

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-05-0495 & 0496** with an Approved Budget for the Contract (ABC) of **Php 318,260.00**;

**WHEREAS**, the BAC has sent the Request for Quotation for this procurement to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

**WHEREAS**, the BAC proceeded with the examination, validation, and verification of all the documents submitted by Albay Computer & Electronics Supplies & Repair; the supplier with the second lowest quoted price, and it was found to be responsive with the requirements of the project;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To award the contract to **ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b) To recommend to the City Mayor of Tabaco the award of contract to **ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR** in the amount of **Three Hundred Seven Thousand One Hundred Twenty Seven Pesos (Php 307,127.00)**.
