**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE SUPPLY & DELIVERY OF VARIOUS CONSTRUCTION MATERIALS AND SUPPLIES FOR THE REPAIR AND MAINTENANCE OF WORK OF CITY HALL COMPLEX, GOVERNMENT FACILITIES, CLASSROOMS AND OTHER VARIOUS LOCATIONS**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-05-0511** with an Approved Budget for the Contract (ABC) of **Php 550,555.00**;
