A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE SUPPLY OF LABOR, MATERIALS AND EQUIPMENT RENTAL FOR THE REPAIR / REHAB OF PNP OFFICE AT TABACO CITY
