A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO PLC TRADING INC. FOR THE SUPPLY & DELIVERY OF MULTIVITAMINS FOR THE MICRONUTRIENT SUPPLEMENTATION OF CHILDREN AGED 6-59 MONTHS OLD, GENDER AND DEVELOPMENT (GAD) OFFICE, TABACO CITY UNDER CONTRACT ID NO. 018-06-2024-GOODS-PB-R1

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply & Delivery of Multivitamins for the Micronutrient Supplementation of Children Aged 6-59 Months Old, Gender and Development (GAD) Office, Tabaco City under Contract ID No. 018-06-2024-GOODS-PB-R1*, with an Approved Budget for the Contract (ABC) amounting to *One Million Five Hundred Fifty-Four Thousand Three Hundred Sixty Pesos (Php 1,554,360.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on August 14, 2024, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:





- a) To declare the bid of *PLC TRADING INC.* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Multivitamins for the Micronutrient Supplementation of Children Aged 6-59 Months Old, Gender and Development (GAD) Office, Tabaco City under Contract ID No. 018-06-2024-GOODS-PB-R1*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *PLC TRADING INC.* in the amount of *One Million Five Hundred Fifty-Three Thousand Five Hundred Ninety-Two Pesos (Php 1,553,592.00)*.
