**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO HYUNDAI ALABANG, INC. FOR THE SUPPLY & DELIVERY OF ONE UNIT BRAND NEW VEHICLE (AUV), CITY VICE MAYOR'S OFFICE, TABACO CITY UNDER CONTRACT ID NO. 021-07-2024-GOODS-PB**

**WHEREAS**, the City Government of Tabaco posted the Invitation to Bid for the *Supply & Delivery of One Unit Brand New Vehicle (AUV), City Vice Mayor's Office, Tabaco City under Contract ID No. 021-07-2024-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Two Million Eight Hundred Seventy-Nine Thousand Six Hundred Pesos (Php 2,879,600.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and opening of bids on July 24, 2024, the BAC received one (1) bid proposal;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

**WHEREAS**, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:





- b) To recommend to the City Mayor of Tabaco the award of contract to *HYUNDAI ALABANG, INC.* in the amount of *Two Million Eight Hundred Fifty Thousand Pesos (Php 2,850,000.00)*.




