A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO PURE GREEN SOLUTION TECHNOLOGY INC. FOR THE SUPPLY & DELIVERY OF WASTEWATER TREATMENT CHEMICALS, CITY ABATTOIR, TABACO CITY UNDER CONTRACT ID NO. 025-07-2024-GOODS-PB

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply & Delivery of Wastewater Treatment Chemicals, City Abattoir, Tabaco City under Contract ID No. 025-07-2024-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Four Hundred Twenty Thousand Pesos (Php 420,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on August 07, 2024, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:






