**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO 4KMB GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF MATERNAL MILK FOR FEEDING SUPPLEMENTATION OF PREGNANT MOTHERS, GAD-CITY NUTRITION OFFICE, TABACO CITY UNDER CONTRACT ID NO. 028-08-2024-GOODS-PB**

**WHEREAS**, the City Government of Tabaco posted the Invitation to Bid for the *Supply & Delivery of Maternal Milk for Feeding Supplementation of Pregnant Mothers, GAD-City Nutrition Office, Tabaco City under Contract ID No. 028-08-2024-GOODS-PB* with an Approved Budget for the Contract (ABC) amounting to *Seven Hundred Ninety-Two Thousand Pesos (Php 792,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and opening of bids on August 20, 2024, the BAC received one (1) bid proposal;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

- To declare the bid of **4KMB GENERAL MERCHANDISE** as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Maternal Milk for Feeding Supplementation of Pregnant Mothers, GAD-City Nutrition Office, Tabaco City under Contract ID No. 028-08-2024-GOODS-PB*; and
- To recommend to the City Mayor of Tabaco the award of contract to **4KMB GENERAL MERCHANDISE**, in the amount of *Seven Hundred Eighty-Four Thousand Pesos (Php 784,000.00)*.
